





#### **WELCOME AND ATTENDANCE**

Jon D'Angelo, NCCDD-Chair, welcomed the members. Jon asked if any Council member with a potential conflict of interest regarding items on the agenda to identify the specific conflict for documentation in the minutes and recuse, as necessary. He thanked the members for their participation on Wednesday.

Bethany Smith conducted the roll call.

#### APPROVAL OF COUNCIL MINUTES

Bethany Smith asked for approval of the February 2025 council meeting minutes. A copy of the minutes had previously been made available to Council members.

**MOTION:** Jon D'Angelo, Chair, confirmed a motion and second were made to approve the February 2025 minutes. The motion was approved by a unanimous vote.

#### **DIRECTOR'S REPORT**

For the Director's Report at the April 2025 DD Council meeting, the Council spent that time discussing recent news about federal funding for DD Councils. There was significant concern raised by Council Members about the importance of DD Councils. The Executive Director (ED) also gave updates at other times during the meeting of the listening session at the North Carolina General Assembly and potential impacts to the I/DD community of potential federal changes to Medicaid. The ED mentioned that while the Director's report was more brief than usual, there will be a more robust update at the upcoming August meeting.

#### FINANCIAL REPORT

Talley Wells, on behalf of Jon D'Angelo, gave a brief report on the financial status of the Council. A copy of the report had previously been made available in advance of the Council Meeting.

#### **NC DHHS UPDATE:**

- Talley welcomed Council Member Representative Zach Hawkins and Representative Terry Brown who discussed the following:
  - Medicaid Expansion and how it can help individuals with disabilities
  - Organizing town halls, making sure US Senators and their staff & regional staff are onboard
  - Concerns of \$880 billion dollars being spent over 10 years on services that can impact individuals with developmental disabilities
  - What's happening at the State level and how folks are still talking about the March 26,
     2025, legislative caucus listening session.
  - o Follow-up with the General Assembly members on:

What the Council is fighting for

Getting firm commitments on the number of innovation waivers

What the plan is for DSP's

- Continue the fight on the road by rallying in other cities/counties
- o Senate Budget: Which was just voted understanding it's not the final budget
- Advocating for the funding for I/DD issues
- o Bills and the website to locate, track and see the progress on bills at https://ncleg.gov/
- Reminded the Council that Senator Lee is the I/DD Co-chair in the Senate

Representatives Zach Hawkins and Terry Brown invited the council to ask questions.

Talley mentioned that the Council receives \$2.1 million dollars and just under \$100,000 of the council's budget comes from the state. Talley also noted that the Trump Administration's current plans do not include the \$2 million in federal funding that the Council currently receives, putting it at risk.

- Representative Terry Brown noted that the topic had been mentioned in the I/DD caucus meeting and echoed by multiple individuals, including Representative Zack Hawkins, Senator Sydney Batch, and himself. He emphasized the significance of financial allocations in understanding priorities, stating that people demonstrate their values through spending decisions.
- Representative Brown highlighted North Carolina's \$33 billion budget and urged attention to federal spending patterns in Washington, D.C. He stressed that analyzing where funds are allocated and where they are not provides insight into how the I/DD community and other groups are perceived. This, he concluded, should guide future advocacy efforts.

Talley welcomed newly retired council member Sandy Terrell, Clinical Officer, NC Medicaid Division of Health Benefits acknowledging her contributions to Medicaid and her leadership within the Division of Health Benefits. He emphasized the importance of dedicated individuals in shaping policies that impact communities and expressed gratitude for her commitment and responsiveness. Talley also invited Sandy to share her plans following her

official retirement, noting the Council's deep appreciation for her work. He announced that LaCosta Parker would be joining the Council and recognized her team for their ongoing support. He concluded by expressing how much Sandy would be missed.

#### **PUBLIC COMMENTS**

Jon D'Angelo introduced Philip Woodward, NCCDD Systems Change Manager, to begin the public comment portion of the meeting. Jon emphasized NCCDD's commitment to providing members of the public with the opportunity to share their comments. He noted that individuals had expressed interest in speaking and highlighted that each public comment would be limited to three minutes. NCCDD Council Members Carol Conway and Kay McMillan were identified as individuals to provide a public comment.

- **Public Comment #1:** Carol Ann Conway, representing PACID (Parent Advocates for Adult Children with I/DD), shared three comments:
  - Legislature List: She expressed interest in obtaining a list of legislators involved in the I/DD Caucus.
  - Quality of Life Improvements: She highlighted the potential for meaningful discussions on non-cost or low-cost changes that could significantly enhance quality of life.
  - Local Network Development: She suggested that if the Council continues, staff-led projects could focus on expanding local networks. These wouldn't have to be PACID but could serve a similar purpose to the ARC Chapters, connecting individuals and families.
- **Public Comment #2:** Kay McMillan, an NCCDD Council member, voiced her concerns and emphasized the urgency for self-advocates to take action, highlighting their vital role.

Talley noted that he would need to step away at noon for a federal update call, though he didn't expect to learn anything new. He mentioned frequent requests from the Council to travel to DC for advocacy efforts. He then introduced Council Member Ryan Rotundo, who shared details about his recent trip to DC.

Ryan shared that he works for the National Down Syndrome Society, which is hosting its Down Syndrome Advocacy Conference from April 28-30, 2025. He explained that the event is intended for individuals with Down syndrome and their families. He noted that the organization's federal policy priorities closely align with the Council's work but don't specifically address state-level issues, such as funding challenges in North Carolina. Ryan mentioned that the event is held annually in April and will continue next year. He also stated that he has reached out to his policy team about potential meetings with Senators Tillis's and Edwards's offices and is available to answer questions or meet individually as needed.

#### **COMMITTEE REPORTS**

Jon D'Angelo requested the presentation of committee reports. Please refer to the committee minutes for a detailed description of each committee's work.

#### **EXECUTIVE COMMITTEE** (EC)

The Executive Committee members met on March 17<sup>th</sup>. The EC approved the January and February meetings. Copies of the minutes were made available to Council members and Jon D'Angelo asked members to review the minutes and reminded council members that the minutes are posted on the NCCDD website.

#### **EC MOTION ONE (of ONE)**

Carol Conway made a motion to:

Approve the 25-26 Administrative budget for \$607,756 in federal funds and \$111,760 in state funds, for a total budget of \$719,516; and to approve the 25-26 Program budget for \$918,189 in federal funds.

Donna Spears seconded the motion. The motion was approved by a unanimous vote.

#### EC MOTION two (of two)

Carol Conway made a motion to:

Approve continuation funding to 23 East Group for the NCCDD Media Relations Program initiative. Funding is approved for up to \$200,000 with a required minimum of 25% non-federal matching funds (\$66,667), for Year 2 (of up to 5), from July 1, 2025, through June 30, 2026.

Sherif Elgindi seconded the motion. The motion was approved by a unanimous vote.

#### **EC MOTIONS In-House Funding Motions:**

#### • In-House Public Policy

Bethany Smith made a motion to:

Approve continuation funding of the In-House Public Policy Initiative for the period of July 1, 2025 - June 30, 2026, for an amount up to \$38,500 with match requirement waived since this is an in-house initiative of the Council.

Kay McMillan seconded the motion. The motion was approved by a unanimous vote.

#### In-House Council Development Fund

Donna Spears made a motion to:

Approve continuation funding of the In-House Council Development Fund Initiative for the period of July 1, 2025 - June 30, 2026, for an amount up to \$40,000 with match requirement waived since this is an in-house initiative of the Council.

Anna Ward seconded the motion. The motion was approved by a unanimous vote.

#### • In-House Conference Funding

Anna Ward made a motion to:

Approve continuation funding of the In-House Conference Funding Initiative for the period of July 1, 2025 - June 30, 2026, for an amount up to \$24,000 with match requirement waived since this is an inhouse initiative of the Council.

Olivia Rose Scott seconded the motion. The motion was approved by a unanimous vote.

#### • In-House Jean Wolff-Rossi Fund for Participants Involvement

Mary Mac Jenkins made a motion to:

Approve continuation funding of the In-House Jean Wolff-Rossi Fund for Participant Involvement Initiative for the period of July 1, 2025 - June 30, 2026, for an amount up to \$30,000 with match requirement waived since this is an in-house initiative of the Council.

Carol Ann Conway seconded the motion. The motion was approved by a unanimous vote.

#### I/DD Speaker, Advisor & Advocate Fund

Kat Boeck made a motion to:

Approve continuation funding of the In-House I/DD Speaker, Advisor & Advocate Fund for the period of July 1, 2025- June 30, 2026, for an amount up to \$5,000 with match requirement waived since this is an in-house initiative of the Council.

Olivia Rose Scott seconded the motion. The motion was approved by a unanimous vote.

Jon D'Angelo noted that, in addition, Marjorie Serralles-Russell, NCCDD Vice-Chair, would provide updates on the EC Committee, the Council's Public Policy Education Committee, and the Ad-Hoc Committee.

EC AD-HOC COMMITTEE UPDATE: Public Policy Education Ad-Hoc Committee.

**Update Provided By:** Marjorie Serralles-Russell, on behalf of the Executive Committee.

Timeframe of Update: Since February 2025.

#### **Key Discussion Topics:**

- The significance of the Council's work.
- Educating policymakers and community leaders on the needs of the I/DD community.
- Policy priorities, including Direct Support Professionals (DSPs) and the waitlist.

Marjorie gave the Council the following updates:

- Discussion on new advocacy strategies and engagement with community leaders.
- Ongoing conversations on Medicaid and Hurricane Helene's lasting impact.
- Focus on recent State and Federal changes over the past four months.
- Continued efforts to keep the I/DD community informed, partnering with Meet the Need and Representative Zach Hawkins.
- The successful Legislative I/DD Caucus Listening Session that was held on March 26, 2025
  - 200 advocates packed the NC Legislative Building, sharing gratitude and hardships.
  - 17 speakers highlighted the importance of the Innovations Waiver and DSP wages.
  - Special thanks to Representative Zach Hawkins, legislative assistant Casey
     Glyph, Beth Field, and Meet the Need colleagues for their advocacy efforts.
- Recent Policy Education meetings that featured Dave Richards (LME/MCO and I/DD advocacy), Dr. Kevin Colquit, Diane Coffey, and Lauren Howard (Hurricane Helene updates).
- Erin Prangley facilitated discussions on Federal-level developments.
- Jill Hinton and Chris Hendricks provided Federal and State updates, including the Self-Advocate Discussion Series.

In closing, Marjorie expressed gratitude and gave special thanks to Representative Zach Hawkins, his legislative assistant Casey Glyph, Beth Field, and Meet the Need colleagues for their advocacy efforts.

Marjorie mentioned that the next Policy Education Meeting will be on Thursday, May 8, 10:30-12:00 PM.

Marjorie encouraged the Council to complete the meeting survey, available in chat and hard copy, to help enhance meeting effectiveness and impact.

#### ADVOCACY DEVELOPMENT (AD) COMMITTEE

Dr. Melissa Swartz, NCCDD staff liaison to the Advocacy Development Committee, reported on behalf of the AD Committee. She expressed gratitude for committee engagement and efficiency in covering the agenda. She provided three initiative updates, including an in-house advocacy leadership network status update.

• Ability Leadership Program of NC (ALPNC):

 Cameron Kempson presented updates; Director Hannah Shoemaker was unable to participate due to technical difficulties. The program, launched Jan. 1, completed its first facilitator training, graduating 11 facilitators. Next leader training begins May 2, with 25 participants selected.

#### Hispanic Disability Advocate Initiative:

 Irlanda Ruiz attended seven outreach events, increasing engagement within the Hispanic I/DD community to 148 members since October.

#### Self-Advocate Discussion Series:

 Four sessions from Dec.–March had 187 attendees, excluding April's session. Based on 131 poll responses, 40 identified as self-advocates, and 47 as parents/family members.
 David Ingram reminded the committee of funding needs for marketing and interpreter services. A formal vote to continue funding will be brought to the Executive Committee.

#### In-House Advocacy Leaders Network:

 Activities are on hold pending federal budget allocations. Dr. Swartz invited inquiries for more details.

Dr. Swartz stated that the committee adjourned at 4:20 PM, with an open call for additional input from members.

#### **COMMUNITY LIVING (CL) COMMITTEE**

Melissa gave an update about the In-House Advocacy Leaders Network initiative. In August the Council approved \$50,000 funding for an in-house effort for a time-limited initiative including 3 – 5 temporary/short-term, part-time Temporary Solutions NCCDD-managed staff to maintain the momentum the existing network members, recruit additional members, and advance the goals put forward by the Council. In January, Staff started recruitment by seeking recommendations from the year-1 initiative staff, but due to the Federal budget situation further activity is postponed.

#### Introduction:

Dr. Charlrean Mapson led an icebreaker activity and then asked for a motion to accept the draft February 2025 minutes. Carol Conway made a motion, and Bethany Smith seconded the motion. The motion carried.

#### Fiscal Update:

Shar'ron Williams provided the fiscal update. She told the committee members that they will vote the next day on continuing in-house initiatives and NCCDD's Media Relations Program initiative.

#### **Initiative Updates:**

#### Autism and I/DD Safety Training for First Responders

Dustin Chandler of the Interaction Advisory Group (IAG) was available for a follow-up discussion to his presentation to the full Council. The committee received two question cards in response to Dustin's presentation to the full Council:

 Olivia Rose Scott asked if an ad hoc committee could be created to help towards IAG's goals for keeping folks with I/DD and other disabilities safe during law enforcement encounters.

Response: Dustin Chandler said in addition to first responder training, there is community training to help community members know how they can improve their interactions with law enforcement officers. He mentioned talking with NCCDD's Hispanic Disability Advocate Irlanda Ruiz to set up a training for the Hispanic and Latino I/DD community.

2. Yvonne Copeland offered assistance with the plan to expand training, saying she started the Crisis Intervention Training (CIT) statewide training with the Local Management Entities/Managed Care Organizations (LME/MCOs). She described it as a well-established system and suggested that NCCDD work with the LME/MCOs to add to it. She noted that it is a 40-hour commitment by law enforcement with fiscal implications, and she said to let her know if she can assist with leveraging the existing CIT system to add the robust I/DD component that NCCDD is rolling out.

Response: Dustin Chandler said CIT is different than the training he leads, but there are similarities. He said de-escalation is the main similarity, but he also covers four or five other topics. He said he would consider working with CIT, but the training he leads is geared toward four hours of I/DD training.

Kay McMillan asked if Dustin would include people with I/DD in facilitating the training, and Dustin replied that the Interaction Advisory Group welcomes any self-advocate or parent to help because police officers getting to know self-advocates can help foster good relationships between the police and the community. Bethany Smith asked how members can get involved, and Dustin said NCCDD will notify its members of the location and time when a training is scheduled. Joshua Gettinger asked if there are some great commonalities with mental health and I/DD. Dustin noted that police officers are getting a lot of mental health training without more specific autism / I/DD training. He added that a law enforcement officer cannot interact with every human being the same way, but more specific training can help officers interact more safely with everyone. Jonathan D'Angelo pointed out the need to address the use of force; for example, people with Down syndrome may have heart conditions or hypotonia (low muscle tone). Dustin said it is important to teach proper restraint methods so as not to injure the person with I/DD and good communication skills. He also mentioned the importance of considering all options before placing a person with I/DD in jail.

Ginger Yarbrough asked if there is a way for the Interaction Advisory Group to get this training into a police academy. Dustin said getting the academy to change their curriculum can be difficult. Dustin expressed a willingness to partner with the academy or get an hour to train their students. He said he shows body camera footage and explains how an officer may have handled the incident differently. He pointed out that it is important to build a sense of community in how law enforcement officers interact with other people, and safety is always the primary goal.

#### **Meet The Need NC**

Beth Field of the Leadership Alliance for Neurodevelopmental Disabilities (LAND) joined virtually along with Cheryl Powell, a person with I/DD, and provided an update on this initiative with a PowerPoint presentation and a video featuring a Medicaid success story involving a person with I/DD. Beth shared the Work Plan goals for Year 4 of this initiative and discussed the I/DD Legislative Caucus Listening Session that occurred at

the North Carolina General Assembly with 17 speakers in Raleigh on March 26<sup>th</sup>. Beth pointed out that the North Carolina Senate budget did not have the funding that people with I/DD need, but there is still a hope that the North Carolina House of Representatives budget will have this funding. Beth talked about hand-delivering 150 letters to members of the General Assembly at the end of February. She mentioned media placements, with 13 stories placed as a result of the event, including WUNC, the front page of the digital *News & Observer*, the *Cardinal & Pine*, and the *Carolina Journal*. Beth said social media is the next place where the initiative will work to activate for grassroots advocacy. Beth thanked NCCDD for its support, and Cheryl pointed out that it felt as if this initiative had moved the needle on addressing the issues it has worked on.

#### **Future Investment Discussion:**

#### **Division of State Health Service Regulation**

Wendy Boone from the North Carolina Division of State Health Service Regulation (DHSR) joined the meeting virtually in place of Robin Sulfridge, who was unable to attend. Ginger Yarbough explained that she invited DHSR to send a representative to this meeting to help NCCDD try to figure out the housing situation for people with I/DD. Wendy said the DHSR currently offers 31 services in licensing different types of facilities from residential to day programs. She said the DHRS offers a monthly training for providers called "Connect the Dots." Wendy mentioned housing rules that go back to 1996 and are part of North Carolina Administrative Code (NCAC) Section 27-G. She said once approval is given to a structure, the request comes back to the licensure training team. Carol Conway said parents of individuals with I/DD have a difficult time understanding the legal issues surrounding setting up housing for people with I/DD, and she suggested that the division communicate its rules to the general public. Wendy said if a residence is serving more than one adult with I/DD, then it needs to be licensed. Joshua Gettinger asked how many facilities has DHSR actually licensed, and Wendy said approximately 3,200 facilities. Kay McMillan asked if DHSR talks to people with I/DD to ask if they want to live in a certain place, but Wendy replied no and pointed out that the Local Management Entity/Managed Care Organization (LME/MCO) takes on this responsibility. Carol Conway said she hopes to have a deeper conversation with Wendy, Robin, and Stacy Silvia to discuss this issue and to ask some questions. Philip Woodward said he will e-mail the PowerPoint to the members.

#### **Current Initiatives and Future Investments**

Carol Conway said she would like to have time to brainstorm about not just housing but also four additional topics. The committee members agreed to have a special meeting the way the committee did in July 2023 to take the time to discuss these items.

#### **Introduction:**

Dr. Charlrean Mapson led an icebreaker activity and called for a motion to accept the May minutes. However, a quorum was not present at the time.

#### **Future Investment Discussion:**

Philip Woodward shared a PowerPoint presentation with some basic information about each of these future investment topics.

#### Appropriate Language Use

Charlrean Mapson reminded the committee members to avoid using jargon, especially especially when talking with legislators or the general public. Carol Conway expressed a concern about the term "lived experience" and later suggested the term "Been There Experience."

#### I/DD Peer Support

Philip Woodward shared how NCCDD has supported three cohorts of a *Peer Mentoring for People with I/DD* initiative. He also pointed out that the North Carolina Division of Mental Health, Developmental Disabilities and Substance Use Services (DMH/DD/SUS) sent out an e-mail on July 8<sup>th</sup>, 2025 with policies and procedures for its NC Certified Peer Support Specialist Program, which is for mental health and substance use recovery.

Philip also shared what he learned from interviewing Brittany Ellis per Talley Wells's suggestion. He said Brittany participated in NCCDD's first cohort and helped to cofacilitate its third cohort, and she now works full time as an I/DD Peer Support Specialist at Johnston County Industries.

Carol asked if North Carolina Employment and Independence for People with Disabilities (EIPD) will do anything to support I/DD peer support or peer mentoring. Talley Wells provided some historical context for how the North Carolina Department of Health and Human Services developed its peer support program and how NCCDD became involved in developing an I/DD peer mentoring program. He also mentioned what has and has not worked with peer support in Tennessee. He pointed out that he sees I/DD peer support as an employment opportunity, so NCCDD's Financial Asset Development Committee has taken the lead on discussing this topic. Juanita Hooker said Ann Marie Webb will present about I/DD peer mentoring at the August Financial Asset Development Committee meeting.

#### **Private Equity Firms**

Philip Woodward shared information about private equity firms, saying that Carol Conway has alerted him, Talley Wells, and Charlrean Mapson that private equity firms are buying up group homes and small disability service providers with a goal to generate a high return for their investors. Philip pointed out that Carol Conway learned about this topic from a presentation that Lisa Grafstein gave at the Disability Rights North Carolina Conference in May 2025. Philip also pointed out that he e-mailed a May 2025 news article from the *NC Newsline* to the committee members. Philip pointed out what he has found in his research:

- Patients, including people with disabilities, have received substandard care when costs are cut.
- Private equity firms might operate in multiple states, so they can be difficult to regulate (for example, is a firm operating in multiple states is shut down in one state, it might continue to operate in other states).
- If a group home closes because of debt or financial non-sustainability, the residents will need to relocate elsewhere. This can be very difficult when North Carolina already has a shortage of affordable housing.

Carol added that five of ten private equity firms are operating in North Carolina I/DD services. Rhonda Cox pointed out that one firm, RHA, is a good partner to Vaya Health and does good work. She mentioned that providers can struggle with cost margins. Carol shared her belief that private equity is invisible and that the economy of private equity is not bad but that it does not belong in disability services. Talley pointed out that understanding the economics of how a service provision is developed is important, and the legislature needs to understand this, too. The group briefly discussed funding issues at the federal level.

#### Housing

Charlrean Mapson started the housing discussion by mentioning Independence Works, a housing organization in the Wilmington area. Carol Conways suggested adopting housing as a top priority and for the Council to consider the no-cost or low-cost things it

can do in this area. Carol also mentioned developing a white paper on housing that discusses a wall of regulations and a lack of coordination. Carol expressed an interest in sharing information about how parents can pass a home on to their adult child with I/DD. The group discussed housing models and situations that they are aware of. Carol shared the need to better educate Robin Sulfridge and the North Carolina Division of Health Service Regulation (DHSR) on the I/DD community's needs and wants. Talley Wells mentioned how the administering housing programs has not gone smoothly for the Local Management Entities/Managed Care Organizations (LME/MCOs) and how he, Philip, and others have a meeting scheduled for July 29<sup>th</sup> to discuss the Targeting and Key Rental Assistance programs. Philip Woodward read the bullet points from the PowerPoint presented that he created to update the committee members on the housing meetings and discussions that he and Talley Wells have participated in between April and July 2025. Carol suggested obtaining a list of potential speakers to present at future Community Living Committee meeting.

#### **Motion:**

With a quorum present, Charlrean Mapson made a motion to accept the April 2025 draft Community Living Committee meeting minutes. Carol Conway seconded the motion. The motion passed. However, Rhonda Cox abstained from voting because she missed the April meeting.

#### Wrap Up:

Philip Woodward said he would e-mail the *Autism and I/DD Safety Training for First Responders* initiative's community Safety Training flyer for August 5<sup>th</sup> in Asheville with the committee members. Bethany Smith said she will participate in an Americans with Disabilities Act (ADA) 35<sup>th</sup> anniversary event in Greenville on July 26<sup>th</sup>.

Charlrean Mapson made a motion to adjourn the meeting. The meeting adjourned at approximately 3:00 p.m.

#### Introduction:

Tony Hall (Chair) called the meeting into session and welcomed the FADC members. He started the meeting with brief member introductions.

**MOTION:** Tony requested review of the February 2025 meeting minutes and called for a motion to approve those minutes. Dreama McCoy made a motion to approve the February minutes, and R.V. Kuser seconded. A vote was taken, and the minutes were approved by unanimous vote.

**Financial Report:** The Financial Report was reviewed by Sharron Williams, Business Officer, and subsequent funding requests for council approval were introduced by David Ingram, Director of Operations.

#### **Initiative Updates:**

Tony Hall introduced Dr. Radscheda Nobles from Winston Salem State University (WSSU) to discuss any questions introduced by the committee. She explained that the appointment to meet with the Provost of WSSU had fortunately been moved to 3:30pm, however, this introductory meeting was important in the process of accomplishing campus leadership support for the development of the IPSE program, so her time with us was limited. She also reported WSSU plans to collaborate with Dr. Pierce and NC Central University (NCCU) HBCU IPSE program. Juanita Hooker provided the background of the recent funding for NCCU and NC State University (NCSU) to begin new IPSE programs. NCSU launched their program in January 2025 with a first cohort of 7 students.

LaCosta Parker requested information to 'catch up' since she was new to the committee. (Staff later emailed a copy of the HBCU IPSE RFA.) Full committee was also reminded to review the links provided in group email earlier in the week for education on current discussions in the news about Artificial Intelligence (AI) and potential changes in hiring trends.

#### **Discussion on Investment Ideas:**

Tony invited the committee to discuss ideas for potential investments. Ryan Rotundo reiterated that Rhode Island had entertained self-employment and entrepreneurship as micro-grants to bolster self-advocate businesses. Juanita Hooker presented a compilation for Entrepreneurships and self-employment, and apprenticeships to provide potential investment ideas for the coming 5-year plan. The presented PowerPoint has several links for further review and was agreed to share with the committee. Ryan also shared two links in the chat for articles on self-employment which were provided to the committee again by email and are also included here.

Lindsay Tipton joined the committee meeting to discuss her work with Access the Achievement. She provided a PowerPoint update on the history, progression, and projection of the current Access to Achievement (A2A) program. The program covers 15 community colleges and currently serving 809 students. (Original records only noted those participants under a person-centered plan). Early outcomes following one full academic semester documents positive impact in college diplomas, college certificates, college degrees, workforce credentials, and workplace preparation credentials. Recent funding and approval to expand to 25 colleges is reported. Kenny Gibbs asked if the program works with EIPD. Lindsay pointed out the program collaborates with the 6 "Bridges to Success' programs operated through EIPD staff. Students may not all achieve a degree but are expected to achieve self-improvement to accomplish a goal of employment. Participants should only be seeking a pathway to employment. Marjorie inquired into the eligibility criteria. Lindsay explained there is a standard criterion that matriculates to college program. Lindsay agreed to meet with Marjorie outside of the meeting to further discuss her questions. This PowerPoint was also to be shared with the committee.

Jacklyn Boheler was scheduled to present on the Action Tool through Work Together NC, but a breakdown in Zoom access prevented her from joining. Committee members asked if we might have an opportunity to hear her presentation on a later date. Staff provided the link to Work Together NC and agreed to see if another showing could be coordinated. Action Plans – Work Together NC

Ryan Rotundo shared information about a Digital App for coordinating meetings with legislative members which he felt might be advantageous in which to invest to better coordinate and expand advocacy access. Advocacy Day - Apps on Google Play.

#### Wrap Up:

Tony Hall reminded the members that the next quarterly NCCDD Council Meeting will be a hybrid meeting and will be held on August 14<sup>th</sup> and 15th at Cary Hilton Garden Inn, Cary NC. Also, that the Policy Education Committee meets every 2<sup>nd</sup> Thursday of the month. R.V. Kuser made a motion to adjourn the meeting. Dreama McCoy seconded. The vote was approved unanimously. The meeting was adjourned at 4:30pm.

# Winston Salem State University HBCU IPSE Program Project Year 1 (of 4)

04/01/2025 - 9/30/2025

#### System Gap Addressed

• Universities and colleges have long recognized the importance of a diverse student body. However, many higher education institutions are missing critical opportunities to expand diversity among students by including students with intellectual disabilities. Students with intellectual and developmental disabilities (IDD) represent a largely underserved population in postsecondary education. Creating a more inclusive environment and teaching using universal design can have a multiplier effect that will, in turn, attract more students. Inclusive post-secondary educational (IPSE) opportunities for individuals with intellectual disabilities (ID) (or students with ID and co-occurring developmental disabilities) have been expanding for decades. However, IPSE remains a reality that few families consider. Attending college can contribute to growth among individuals with intellectual disabilities in many of the same ways traditional students benefit from postsecondary education: academic and personal skill building, independence, self-advocacy, friendships, and, perhaps most importantly, employment skills.

#### **Initiative Goals**

- Develop an initial, robust plan for creating an IPSE program at the school to begin as a pilot in either August 2026 or January 2027.
- Work with University Admissions to modify/amend current admission policy to build a pathway for students with IDD to matriculate at WSSU
- Identify potential campus and community organizations with expertise in mental health, academic support, leadership, and career readiness by the end of the first six months (Year 1) to establish a collaborative commitment for accessibility
- Gain academic institution leadership approval of planned program and planned budget.
- Conduct a curriculum review of existing WSSU courses to identify at least five relevant courses that align with IPSE goals by the end of Year 2.
- Organize Training Materials
- Develop a recruitment plan for students who will attend and the number of students the program will support once established.
- Outline a detailed evaluation plan to monitor and evaluate the performance activities and outcomes, focused on gathering information to improve the program.
- Initiate community collaborations to build into career development which can lead to competitive employment for students with ID or ID and developmental disabilities.

#### **Description of Activities**

- Meet with campus leadership and gain approval for implementation of a specialized admission process which evaluates students based on individualized assessments, personal interviews, and educational history rather than GPA and standardized test scores.
- Collaborate with contacts from campus stakeholders (including the university counseling center, services for students with disabilities office, university advising center, and other offices) and community organizations contacts
- Coordinate campus involvement and outline collaborative commitment to create accessibility for students with IDD
- Partner with Hispanic-serving organizations within the community and on campus, cultural centers, and advocacy groups to further broaden university outreach
- Collaborate with IPSE Leaders on training and education curriculum.

#### **Outcomes to Date**

- · Letters of commitment from campus leadership for support of IPSE program development
- Appointment of key campus stakeholders for coordination of campus and community organization engagement, including the hire of program manager and student staff to facilitate culturally diverse outreach.
- Collaboration on curriculum review for universal design, and co-development of instructional materials with IPSE Leaders
- Program Leaders to attend Mid-Atlantic Regional Alliance for Inclusive Higher Education Conference July 2025



## Ability Leadership Project of NC – CenterED Resources

**Year 1 of 1** 1/1/2025 – 12/31/2025

#### **System Gap Addresses**

- Developmental disabilities policy-based advocacy leadership development training programs involve high cost, outcomes tracking challenges, and barriers to long-term participant follow-up.
- There are no policy-based advocacy leadership development training programs where people with intellectual and other developmental disabilities (I/DD), parents, professionals and other stakeholders train together.
- Individuals with I/DD are rarely training facilitators or coordinators for policy-based advocacy leadership training initiatives geared towards individuals with I/DD and their families; and nearly never facilitators and coordinators if the leadership training program is geared toward professionals.

#### **Initiative Goals**

Graduates of the ALP-NC leadership development training will gain the skills necessary to effectively advocate for their self and others (e.g., speak to policy and other decision-makers, give testimony, etc.) at local state and federal levels to promote systems change. CenterED Resources will:

- By December 31, 2025, implement one cohort of the ALP-NC Facilitator Certification Program, graduating at least eight (8) new facilitators with at least 50% identifying as IDD.
- By December 31, 2025, implement two Leader cohorts with the goal of graduating 30 new Leaders with at least 50% identifying as IDD.
- Ensure training approach and content that aligns with ALP-NC's values, methodologies, and mission, specifically addressing the needs of people with I/DD and their family members.
- Integrate practical examples and relevant case studies to enhance the training's applicability and effectiveness.
- Update facilitating strategies and techniques to suit the facilitators' skill sets and learning styles, focusing on interactive, participant-engaged methods.
- Incorporate technological tools and digital platforms to reflect best practices in digital learning.
- Refine as needed, the learning objectives, language, and terminology to closely align with ALP-NC's goals, target audience, and mission.
- Ensure the training sessions meet the operational needs and preferences of the initiative staff and leaders.
- Maintain contact with former training graduates and the 2025 training graduates.
- Work with the NCCDD to develop and maintain a method for long-term contact with graduates.

#### **Outcomes to Date**

ALP-NC Contractor CenterED Resources (CR) started January 1, 2025. Lead staff from CR worked with former ALP-NC contractor Community Bridges Consulting Group (CBCG) whose contract ended December 31, 2024. Prior to that, CBCG worked with Disability Rights NC for pilot programming of the ALP-NC. Since start up implementation the initiative accomplished the following:

- Individuals with I/DD began having lead roles and co-lead all aspects of the training, including training coordination, training facilitation, and evaluation.
- Finalized the Inclusive Leadership Development Training curriculum.
- Developed Facilitator's Guide and accompanying facilitator's tools. Created a Facilitator Orientation including 2 orientation videos.
- Graduated 98 trainees (including 54 with Disability Rights NC and 32 Leader Advocates with CBCG who held 3 separate Leader Cohorts). Cohort 1 with CR began May 2, 2025and graduated 12 Leaders on June 20, 2025. Cohort 2 with CR begins August 22, 2025 and ends October 17, 2025. An ALP-NC Q&A session for Cohort 2 applicants was held on June 16<sup>th</sup> to offer insight into what to expect during Leader training.
- Maintaining 11 Facilitator Leaders via 2 Facilitator Education Cohorts. Facilitators are trainers of diverse representation including three individuals with I/DD.
- CR is maintaining distinct roles, including: a Director, Senior Facilitators, Junior Facilitators, Producers, and Leader Advocates. Created distinct roles including: Co-directors, Senior Facilitators, Junior Facilitators, Producers, and Leader Advocates.
- Maintaining Monthly Facilitator and Alumni Meet-Ups and Learning Team meetings. CR is maintaining the monthly e-newsletter. CR will maintain practical assessment plans and practices.
- Instituted on-going Leader engagement efforts including in-person advocacy at the May 2024 I/DD Caucus.



### **Autism and I/DD Safety Training for First Responders**

Year 1: October 1, 2024-September 30, 2025

#### **System Gap Addressed**

- People with I/DD and other disabilities are unnecessarily jailed, injured, and even killed during routine interactions with law enforcement officers and other first responders.
- Law enforcement officers and other first responders do not always receive training on how to appropriately interact with people with autism and I/DD.

#### **Initiative Goals and Timeline**

- Research the autism and I/DD safety training landscape in North Carolina for first responders, including law
  enforcement officers, to determine where the greatest areas of need exist.
- Pilot a training or a series of trainings in one or more areas of need.
- Scale the training statewide after the pilot to train first responders, including law enforcement officers, and people working in North Carolina's justice system as well as people with I/DD and their caregivers.

#### **Description of Activities**

- Conduct an inventory of available trainings related to I/DD for law enforcement and/or related crisis response in North Carolina and nationally and conduct a gap analysis of what is needed for law enforcement and/or related crisis response to determine where training and education needs exist in North Carolina.
- Meet with state agency officials, non-profit organization officials, and officials at private businesses who are involved in training law enforcement officers or providing crisis response for people with I/DD in North Carolina.
- Do outreach to diverse populations, including North Carolina Hispanic and Latino I/DD community and North Carolina's black, indigenous, and people of color (BIPOC) I/DD community.
- Develop and implement, adapt, or utilize a pilot training for first responders, including law enforcement officers, crisis response teams, and related personnel.
- Scale the training statewide after completing the pilot training during Year 1.

#### **Achievements and Outcomes to Date**

- Grantee connected to the North Carolina Department of Public Safety, the Autism Society of North Carolina, and various individuals with I/DD and their family members who are concerned stakeholders in this work.
- Presented at NCCDD's February 2024 Self-Advocate Discussion Series session with 76 total participants.
- Initiated a conversation about disclosure cards and blue envelope programs (tools to help people with autism communicate with law enforcement officers).
- Conducted research to determine current training needs and regions to focus on for providing training in North Carolina.
- Scheduled the first pilot training for law enforcement in Asheville on August 5<sup>th</sup>, 2025 and the first pilot training for the I/DD community in Asheville on the same date in partnership with the Buncombe County Sheriff's Office.
- Initiated a conversation with the Raleigh Police Department to do a pilot training for law enforcement in Raleigh later this year.

#### **Expected System Change as Result**

- Increase the quality of interactions between people with I/DD and first responders, especially law enforcement officers.
- Improve the number of positive interactions between people with I/DD and first responders, especially law enforcement officers.
- More individuals with I/DD and their caregivers as well as first responders will stay safe during interactions with each other, particularly in times of emergency or crisis.
- Fewer individuals with I/DD will be unnecessarily arrested, injured, or killed during interactions with law enforcement officers and other first responders.



#### Self-Advocate Discussion Series

10/1/2024 - 9/30/2025

#### **System Gap Addresses**

NCCDD has the need to attract, prepare, organize and mobilize NC self-advocates for influencing social and systems change. More NC self-advocates interested in advocating the value of people with disabilities are needed to actively build and maintain relationships with NC legislators and decision-makers. In addition, self-advocates will be supported to develop working relationships and a network among themselves.

#### **Initiative Goals and Timeline**

The NCCDD sponsors a monthly NC self-advocate discussion series facilitated by the NCCDD Policy Education Coordinator, NCCDD self-advocate executive committee members, and additional coordinated participation by other NCCDD self-advocate members and staff. One- hour discussion sessions occur monthly. The discussion series is coordinated by NCCDD Advocacy Development Committee staff and by the NCCDD Policy Education Coordinator with support from NCCDD administrative staff, and the Hispanic Advocate initiative staff.

Each session is dedicated to addressing one IDD advocacy topic. Facilitators provide background on the topic and support attendees to share personal stories related to the topic. Sessions aim to be practice forums for using personal stories to build relationships with NC decision-makers and legislators. Experts, trainers, and decision-makers are invited to designated sessions to offer approaches for accessing, conversing, and following up with legislators and policymakers.

#### **Description of Activities**

Sessions share and hear stories of lived experience and meet NC Self-Advocate leaders and topic experts. Sessions are dedicated to sharing topic oriented personal stories, NC self-advocate network relationship building, NCCDD awareness, and just being with others who have common interests. Expect sharing and hearing personal stories of lived experience about topics important to IDD advocacy. Join the conversation, spend time with others who have common interests, and become part of the NCCDD community. Sessions balance training, knowledge sharing, and attendee participation to convey the best ways to use our personal stories to discuss topics important to I/DD advocacy.

#### **Achievements and Outcomes to Date**

Since Nov. 2021 start through June 2025:

- 42 # of Self-Advocate Discussion Series sessions held
- 697 # of People Registered in FFY 2022 to attend sessions (includes duplicates and staff)
- 1,059 # of People Registered in FFY 2023 to attend sessions (includes duplicates and staff)
- 966 # of People Registered in FFY 2024 to attend sessions (includes duplicates and staff)
- 1562 # of People Registered in FFY 2025 to attend sessions (includes duplicates and staff)
- 738 # of People Registered to date self-identified as person with IDD (includes duplicates)
- 26# of Topics discussed at series sessions (e.g., Valuable Principle, Voting, How to Talk to Legislators, Employment, Organized Advocacy, Anniversaries: ADA, DD Act, NDEAM, Transportation, DSP Crisis/Waiting List, Emergency Preparedness, Relationships, Planning for the Future, Engaging Safely with Law Enforcement, Adulting with IDD, Art & Advocacy, and more.)

## NCCDD Media Relations Program - Year 1 of 5

7/1/2024 - 6/30/2025

#### **System Gap Addressed**

- The North Carolina Council on Developmental Disabilities (NCCDD) is federally mandated by the Developmental Disabilities Act (DD Act) to fund initiatives that influence policy and promote independence, inclusion, and selfdetermination of North Carolina citizens with intellectual and other developmental disabilities (I/DD) and their families.
- There are approximately 180,000 individuals with I/DD residing in North Carolina.
- NCCDD is responsible for advocacy, community capacity building, and systems change achieved by sharing information learned from its funded initiatives with elected officials, state leaders, and community organizations.
- NCCDD determines its funding priorities with significant public input from individuals with I/DD and family members across the state through its five-year state planning process.

#### **Initiative Goals and Timeline**

- Implement a strategic marketing plan to raise awareness of the mission of NCCDD and its resources available to elected officials, state leaders, and local organizations across the state.
- Assist NCCDD in communicating the work of existing grant initiatives information with key decision makers at the state and local level.
- Assist NCCDD in the communication of public policy issues that impact the independence and inclusion of individuals with I/DD and their families.
- Assist NCCDD in community outreach and collection of public input from individuals with I/DD and their families
  on opportunities and barriers they face in everyday life to guide the development of funded grant initiatives, public
  policy goals, and systems change activities.

#### **Description of Activities**

- Marketed the work of the Council through social media messaging. Social media posts were created and shared through NCCDD's Facebook and Instagram accounts.
- Marketed the work of the Council through email marketing. 36 email announcements were shared with an average of 7,155 subscribers.
- Supported Council activities and campaigns including Self-advocate Discussion Series, ALP-NC applications,
   I/DD Listening session, Five Year Plan survey, Policy Education monthly meeting, The Council Presents webinar series, and more.
- Developed newsletters and other material in English and Spanish and accessible audio that Council members and the general public can use to share information about issues that impact individuals with I/DD.
- Distributed weekly updates, as needed, via email marketing to share events and updates of interest to the I/DD community.
- Continued with the Council's website upgrade. Completed the new layout/design, conducted the content audit, received input from Council, and continue to work on finalizing the site before launching.

#### **Achievements and Outcomes to Date**

- Increased public presence through local media reports, press releases, public policy input, and collaboration with communications liaisons across state government.
- Continued outreach via social media and website formats to share outputs from the Council and to solicit greater input from individuals and families across the state.
- Distributed 36 email campaigns to 7,155 subscribers with a 37% open rate.

#### **Expected System Change as a Result of Initiative**

- Raise awareness of the Council across the state as a consensus-builder on the broad issues that affect people with I/DD and their families.
- Identify strategies to raise awareness of funded initiatives and opportunities for collaboration.
- Increase the number of people who understand and champion the removal of barriers in systems that impact independence, inclusion, and self-determination among those with I/DD.



## Meet The Need NC - Year 4 of 4

10/1/2021 - 9/30/2025

#### **System Gap Addressed**

- It is hard for individuals, families, and staff to find, navigate, keep, and best use services.
- Many people who need help and support are not getting it. People can't ask for help if they do not know what help is available.
- People of all ages with I/DD and their families are just surviving, not thriving.
- There are a lot of changes and transitions going on, including Medicaid Transformation and Expansion, and 1915(i).
- The Registry of Unmet Needs (RUN) is more than 18,700 and growing; the number of slots is not keeping up with the growth.
- A Direct Care/Service Professional (DSP) work force shortage is a key factor impacting the ability of individuals to live in the community.
- People don't always agree on what is best for people with I/DD to live or work in the community.
- All of these factors have led to significant unmet service and support needs for North Carolina's I/DD community.
- There are increased health disparities for those in underserved communities, including Black, Latino/Hispanic, Native American and rural communities.

#### **Initiative Goals and Timeline**

- Be a catalyst for I/DD systemic change in NC using a Collective Impact model to meet the service and support needs of those with I/DD and their families throughout their lifespans. Focus on reducing the Innovations Waiver Waitlist and Direct Care/DSP work force shortage.
- Garner the support of the I/DD Community as a whole and other stakeholders groups to meet the specific goal of the NCCDD-funded portion of initiative: Meet the service and support needs of those on the Registry of Unmet Needs.
- Develop and expand a statewide I/DD grassroots lived experience movement to become the message driver of I/DD systems change and ensure sustainability of the initiative.
- Drive a groundswell of interest regarding the Meet the Need NC movement, including underserved communities.
- Understand and impact the level of understanding of those outside the I/DD Community regarding I/DD.
- Continue putting processes in place to manage initiative interest, integrate programming and grow support for community living options for those with I/DD.
- Increase stakeholder awareness and understanding around key issues that impact I/DD services and supports, including Innovations Waiver/Wait list, Direct Care/DSP workforce shortage, Medicaid Transformation, Tailored Plan, Tailored Care Management, 1915(i), and Medicaid Expansion; Inspire the use of plain language and accessible communications for beneficiaries.
- Inspire the use of plain language and accessible commutations to beneficiaries.
- Build and maintain authentic relationships with key stakeholder groups, including state agencies and understand populations, around meeting the service and support needs of I/DD Community.
- Listen well and consistently to constituencies across the state to further understand the similar and diverse service and support needs, including underserved populations, amidst ongoing changes in our Medicaid and Managed Care systems.
- Engage stakeholder groups in and outside of the I/DD community.
- Continue to refine Shared Measurement as part of the Collective Impact model and develop an integrated 2024-2025 Work Plan.
- Meet overall 2024-2025 Work Plan goal: By the adjournment of the 2025 NCGA long session, Meet the Need NC will educate key members of the NCGA on the urgent need to the impact of reduce or eliminate the Innovations Waiver Waitlist while supporting the growth of a pool of DSP workers to ensure community living choices.

#### **Description of Activities**

• Increase stakeholder awareness and understanding around key issues that impact I/DD services and supports through email, website posts, social media posts, and presentations in and outside I/DD Community, and joining planning efforts for an upcoming I/DD Legislative Caucus Listening Session.

- Ongoing participation in other collective impact initiatives and advisory groups relating to initiative issues using
  key values and guiding principles for interactions, form and maintain a highly engaged "Advisory Collaborative" of
  leading key stakeholders, thought leaders, and organizations with diverse perspectives from the developmental
  disability community to advise initiative that meets quarterly.
- Hold regular meetings for a lived experience advisory group that meets monthly to develop content for initiative's communications vehicles and to grow a grassroots network across the state.
- Develop communication materials to reach community-based organizations to mobilize, focus, and amplify initiative's messages across the state.
- Educate/inform individuals with I/DD and their families at the community level about the Innovations Waiver, waitlist, and services and supports available while waiting.
- Build and maintain authentic relationships with key stakeholder groups, including state and local policymakers and other groups outside of the NC I/DD Community.
- Listen well and consistently to constituencies across the state to further understand the similar and diverse service and support needs, including underserved populations.

#### **Achievements and Outcomes to Date**

- Formed and maintained an Advisory Collaborative, lived experience advisory group, and 2024-2025 Work Plan Task Force across developmental disabilities, level of need, lifespan, region, and marginalized communities.
- Assisted in identifying diverse groups of people with I/DD lived experiences for March 2025 I/DD Caucus meeting
  at the NC General Assembly for a listening session, and helped organize a press conference for the event.
- Delivering presentations on Innovations Waiver Pathway and Tip Sheet Toolkit to community-based meetings to help educate and inform on the Innovations Waiver, waitlist, 1915(i) and other tips of things to do while waiting for an Innovations Waiver slot.
- Ongoing set of communications vehicles including social media, webinars, newsletters, podcasts, website, and toolkit which deliver an integrated set of I/DD targeted awareness messages to date. Grew targeted mailing list to approximately 2,000 people.

#### **Expected System Change as Result of Initiative**

- Reduce/eliminate Innovations Waiver Waitlist and Direct Care/DSP work force shortage.
- People with lived experience at the community level are key to driving system change along with seasoned state-wide policy advocates from a bottom up and top-down approach.
- Disability groups work together to realize the value of collective impact.
- Individuals with developmental disabilities join together with families to form a united grassroots movement across the state.
- Those with I/DD lived experience are more strategically joined with policymakers to tell their stories in a unified, focused way.
